# Description

#### **Domains of Application**

The formulation of **CCI Neo Erase** is designed to remove rust and stains safely, quickly, and effectively from corroded iron and steel prior to painting. It removes stains from marble and tiles and brings back its new shine. **CCI Neo Erase** is a good stain remover from domestic household appliances like basin, sink, taps, brass items etc.

#### **Method of Application**

- ✓ Shake contents before use.
- ✓ Apply over the corroded area with a brush, roller, or sponge. Allow a dwell time of 10 to 25 minutes depending on the amount of rust / stains to be removed.

- ✓ For heavy encrustation, it is advised to use a wire brush prior to applying CCI Neo Erase.
- ✓ Rinse thoroughly with water.

### Coverage

Coverage will vary depending on the extent of rusting and roughness on the surface. 1 kg material covers 6  $m^2$  to 7  $m^2$  smooth steel surface.

#### Packaging

1 kg, 5 kg, and 20 kg buckets.

#### Shelf Life & Storage

12 months from the date of manufacturing when stored in unopened, original sealed and dry condition at a temperature range from  $+5^{\circ}$ C to  $40^{\circ}$ C.

#### Precautions

- ✓ Store the material at the 5°C to 40°C temperature range in a shaded cool place.
- Failure to comply with the recommended storage conditions may result in premature deterioration of the product.

#### Safety

- ✓ Wear hand gloves, safety shoes and safety goggles while using and handling the product.
- ✓ In case eyes or mouth are affected, wash with plenty of clean water and seek medical treatment immediately.
