Coverage

- ✓ Based on the width, depth of the joint and size of the various type of tile and stones
- ✓ Note: It is always good when calculating coverage to allow 10% extra for wastage and spillage.





Mixing Ratio

Part A (Resin: 2-part), Part B (Hardener: 1-part), Part C (Filler Powder: 8-part).

Note: The ratio of the filler powder will differ based on workable consistency on wall and floor.

Packaging

5 kg kit. [Part A (Resin) – 833 g, Part B (Hardener) – 417 g, Part C (Filler Powder) – 3.75 kg].

Colour

Refer Neo Tile EPG shade card.

Shelf Life & Storage

Resin & Hardener - 12 months from the date of manufacturing.

Filler: 24 months from the date of manufacturing.

The above shelf life is applicable only when the product is stored in un-opened, original sealed and dry condition at a temperature range from +5°C to 40°C.

 using and handling the product.
